2. You agree to take an obligation to provide official recognition statement from the Centre for Quality Assessment in Higher Education (CQAHE) in Lithuania about recognition of your secondary school education certificate in one month after receiving this conditional letter. Please note if SKVC answer will be negative you will not be able to continue studies at university. In this case neither application, nor tuition fees will be reimbursed to you. If SKVC answer will contain additional conditions, you will need to fill it. Without SKVC recognition certificate your admission process will be postponed till next intake.

3. You agree to meet the financial requirements laid down by the university:

The tuition fee for the programme – 3480 EUR per year (for 60 ECTS).

Additional fees might occur only for the additional courses if necessary or required.

Application and tuition fees should be in one month period after issuing this conditional letter.

If conditions are met, you will receive an official acceptance letter from Klaipėda University and admission procedure is going to be started.
